

^{*} Maximum number of animals that can be maintained. Exceeding this number, or the presence of roosters, may be grounds for cancellation of a permit. A permittee that wishes to increase the number of animals allowed or to substitute or add a different species to those listed on the permit is required to apply for a new permit (including a new petition) and pay the appropriate fee.

Permit Application and Petition must be returned to the Animal Control Center, 1285 Jessamine Avenue W., Saint Paul, MN 55108 within ten (10) days of application or permit will be denied.

The applicant/permittee shall at all times keep the animals in accordance with all the conditions prescribed by the environmental health officer/Animal Control Center, or modification thereof. Failure to obey such conditions will constitute a violation of the provisions of the Saint Paul Legislative Code, and may be grounds for cancellation of a permit.

I understand that if the permit is for Chickens, only Hens are allowed. No Roosters.
