Dear Mr. Pinter:

The Minnesota Pollution Control Agency (MPCA) staff in the Voluntary Investigation and Cleanup (VIC) Program has reviewed the "Summary of Underground Storage Tank (UST) Sump Sampling Events Memorandum" (Report), dated December 5, 2012, for the Ford Twin Cities Plant site, located at the address referenced above (the Site). The Report was prepared and submitted on your behalf by ARCADIS U.S., Inc. (ARCADIS).

The Report presents the results of the annual sampling of a sump (Feature 46) within a former waste solvent UST basin (Feature 36) located south of the Paint Building. From approximately 1987 to 1992 the USTs were used to store spent solvents generated during auto body painting operations. Because of the shallow bedrock in this area (the Decorah Shale is six to eight feet below grade), the bottom of the former tank basin is completed several feet into the bedrock.

A release from the UST system was discovered in 1992 and the tanks were subsequently removed during an interim response action conducted under the oversight of the MPCA's Superfund Program. The former UST system was removed from the State Superfund List in 1993, although pumping of the sump and periodic monitoring of the sump discharge was an ongoing requirement. In 2007, MPCA oversight of the annual monitoring of the sump was moved to the VIC Program.

Prior to plant closure in December 2011, perched groundwater that accumulated in the former tank basin was directed to the sump via a drain tile system and then pumped to Ford's wastewater treatment plant. The concentrations of volatile organic compounds (VOCs) in the sump have decreased considerably over the past few years. During the 2012 sump sampling event, all detected VOCs were at concentrations less than the Health Risk Limits established by the Minnesota Department of Health.

The Report is approved. Although the sump pumping is discontinued, the collection of accumulated water in the sump will need to be monitored and evacuated if necessary. Please submit a plan for discontinuing the sump pumping and initializing regular monitoring of the drain tile system and sump until its demolished and regular monitoring of the three monitoring wells MW-4, MW-5, and MW-6.
