PERMIT SESSIONS: The day is divided into two sessions. If you would like to reserve the entire day, you are required to pay for two sessions. Permits must be processed at least seven business days prior to the event. Note: For groups of 1000 or more, please see Large Events and Community Festival Reservations

Alcohol – The possession or consumption of alcohol is prohibited in this park.

CHANGES TO PERMITS: There will be a \$25.00 charge each time you alter your picnic permit (session change, date change, location change). Changes to permit will be accepted up to 7 business days prior to the reservation date.

CHARGE FOR VIEWING FACILITIES PRIOR TO EVENT: There will be a \$25 charge for persons requesting to view the facilities before the event. You must contact the permit office at least 7 business days prior to your permit so arrangements can be made for a staff person to show you the facility.

REFUNDS: No refunds will be issued for cancellations less than 30-days prior to the reservation date. Permits under \$150 will "NOT" receive a refund. Permits over \$150 will receive 50% of the permit cost. No refunds are given due to weather conditions. If a permit is issued less than 30-days of an event, and the permit is canceled, the permit fee will be non refundable.

As a reminder: there is no reserved parking in any Saint Paul park.

RENTAL AND RATE INFORMATION:

- Prices include Minnesota sales tax in the amount of 7.625%.
- Non-Profit/Tax Exempt rates are available on facility rental fees as listed below to groups who provide proper documentation of such status <u>at the time the permit is issued</u>. The large group, tent, large game and inflatable fee prices are not discounted except for the reduction of fees due to tax exempt status.
- For groups that are non-profit but not tax exempt, sales tax will be added back into non-profit/tax exempt fees listed.
- The rates listed are for groups of 99 or less. If the rental is for a group of 100 or more, there are additional fees (refer to the large group fees).

ADDITIONAL DEPARTMENT OF PARKS & RECREATION FACILITIES AVAILABLE FOR RENTAL

CLARENCE W. WIGINGTON PAVILION ON HARRIET ISLAND 200 Justus Ohage Boulevard, 55107

The pavilion is located on Harriet Island across the Mississippi River from downtown Saint Paul. It is a beautiful 5,000 sq. ft., heated, accessible building with free parking. The pavilion is a year-round rental facility. Reservations are taken from City of Saint Paul residents the first business day of the month 13 months in advance of the event date and non-residents may apply the first business day of the month 12 months in advance.

COMO LAKESIDE PAVILION 1360 No. Lexington Parkway, 55108

This rental facility consists of two areas: a mezzanine level that overlooks the main floor and a 3rd floor banquet/meeting hall. The mezzanine level seats approximately 50 people; the 3rd floor banquet hall seats 160-200 depending on seating set-up. Tables and chairs are included with the rental of these two rooms. A promenade area is also available for rental.
