- A. Bob Spaulding called meeting to order and reviewed Group Agreements.
- **B.** Eriks Ludins provided an update on road turn back negotiations. Will have notification in mid to late January regarding grant fund request with Ramsey County. Still in financial negotiations with Dakota County.
- C. Alice Messer provided update on roadway maintenance/operational issues and environmental cleanup work currently underway in park. Roadway is currently in conceptual design phase and operational/maintenance issues are future discussion item as roadway design becomes more refined.

Environmental cleanup efforts are about 25% complete. A large stockpile of reusable material is growing in the park. Currently, the contractor has removed creosote wood paver, scrap metal, and small amount of asbestos containing material. Work is estimated to be completed at the Marina Demolition Site late January 2011. Work at the Park Dump Site will begin spring 2011.

D. Michael Schroeder presented conceptual roadway alignment plans.
