

## **TENTS/CANOPIES PERMIT APPLICATION**

**APPLICATION INSTRUCTIONS:** This application must be completed by event sponsor and submitted not less than **15 days prior** to the event.

\* \* Individual Canopies in excess of 400 sq. ft. \* \*

**CANOPY-** *A* structure, enclosure or shelter constructed of fabric or pliable materials supported by any manner, except by air or the contents it protects, and is open without sidewalls or drops on 75% or more of the perimeter.

**TENT-** *a structure, enclosure or shelter constructed of fabric or pliable material supported by any manner except by air or the contents that it protects.* 

**STRUCTURE TENTS or AIR-SUPPORTED STRUCTURES (sometimes called Clearspan tents)** - An airinflated, air-supported cable or frame-covered structure as defined by the international building code or is attained by air pressure, and occupants of the structure are within the elevated pressure area and not otherwise defined as a tent or canopy will require a <u>Building Permit</u>.

Incomplete information will result in rejection of application. No work can begin prior to approval.
