#### INSTRUCTIONS FOR DEMOLITION / WRECKING PERMITS

**NOTE:** Pre-Demolition Inspections are required in Ramsey County for all full residential and commercial demolition projects and are also required for partial commercial remodeling and demolition projects. To set up a pre-demolition inspection, call 651.266.1199. ### **FEES:**

Wrecking of buildings or structure. Five dollars (\$5.00) per one thousand (1,000) cubic feet or fraction thereof, minimum fee \$85.00.

Zoning Review Fee: \$90.00 for each structure (zoning fee may be waived for accessory residential garage if removed at the same time as principal structure or when the demolition is to accommodate new construction and there is an active site plan review under way for the new construction.)

Building Inspectors are in the office for inspection requests between 7:30 AM - 9:00 AM, Monday - Friday. Phone number is 651-266-9002.
