Subject: CIB Proposal for Safe Routes to School plan development

To the Capital Improvement Budget Committee:

I'm writing on behalf of St. Paul Smart Trips to express our support for CIB funding for developing a Safe Routes to School plan as proposed by the City of St. Paul's Department of Public Works. St. Paul Smart Trips is a 501(c)(3) non-profit organization that improves access and mobility for those who travel in and around St. Paul. This project is also endorsed by St. Paul Women on Bikes, a St. Paul Smart Trips program that works to make riding a bike in St. Paul safer and easier for women, children, and families and by St. Paul Walks, a program of St. Paul Smart Trips focusing on getting drivers to slow down for pedestrians, specifically at intersections, whether they are marked or unmarked.

Last October, a young boy was hit and severely injured on Rice Street in St. Paul walking to school. These tragic incidents are far too common and can be avoided. Programs like Safe Routes to School provide important tools for schools to safely get children to and from their classes as well as infrastructural upgrades near schools to help ensure crashes like this don't happen.

Additionally, Safe Routes to School programs improve public health by encouraging active transportation for students to get to school. In an era where children are leading far more sedentary lifestyles than previous generations, is it important to provide safe places for them to walk and bike to increase physical activity as part of their daily commute.

Lastly, these benefits do not only apply to children going to school. Neighbors reap the rewards of Safe Routes to school programs, too. The infrastructure that results from these funds often leads to higher rates of biking and walking in the surrounding area. This positively impacts individual and public health as well as the local economy.

For these reasons, we believe that a Safe Routes to School plan must be updated and implemented in St. Paul to ensure the long-term health and safety of everyone traveling in and around our city.



Dear CIB Committee:

Transit for Livable Communities is writing in support of the \$200,000 request for funding for to undertake or update planning for Safe Routes to schools in Saint Paul.

Safe routes to schools projects – sidewalks, trails, on-street routes, signage, curb extension, traffic signal upgrades – all contribute to a more walkable, bikeable city for students and community members. Walking and bicycling to school leads to healthier more engaged students and saves families and the school district money on bus/car travel. More walking and bicycling also reduce traffic congestion near schools.

With funding to update and improve the city's Safe Routes to schools plan, the city will be better able to prepare timely and competitive applications for state and federal funding. If a transportation funding package is adopted by the Minnesota legislature this year, an updated plan could put the city in a very good position to compete for new regional funding that has been proposed by the Governor and the Senate.

Saint Paul Capital Improvement Committee:

I write in support of providing planning funds for Safe Routes to School (SRTS) projects in Saint Paul. The health benefits and educational advantages of bicycling and walking transportation for K-12 students are well documented and cannot be overstated. <u>http://www.saferoutesinfo.org/</u>. Initiatives across the country have created a growing SRTS movement. Parents have been, and will continue to be, resistant to this movement here unless their children's trips are protected with safe infrastructure.

Saint Paul has not taken full advantage of the significant and expanding funding opportunities for SRTS at the state and federal levels. And there is more urgency to complete a planning process to be able to tap the funds. "Due to the increased benefits seen from planning, MnDOT is moving towards requiring SRTS planning efforts for infrastructure. 70 percent of 2013 implementation grants awarded had completed SRTS planning," according to the MnDOT website http://www.dot.state.mn.us/saferoutes/grants.html. MnDOT reports \$700,000 of SRTS federal awards announced in 2014. It is critical for Saint Paul to have a SRTS completed plan to be able to access these resources and improve infrastructure and programming.

I hope you will give full attention to this opportunity as part of the CIB process.
