I am submitting this letter in strong support for the 2016/2017 Capital Improvement Budget proposals to upgrade the Highland Park Community Center Play Area and the Highland Park Community Center fields.

As a parent, educator, and neighborhood resident, I feel it is important to continue to offer clean, safe, and updated facilities to neighborhood children who can enjoy a quality outdoor experience while enhancing neighborhood and community pride.

Speaking specifically about the Highland Park Community Center Play Area, the fact that the playground equipment is outdated and there is noticeable vandalism and significant wear and tear on some of the playground structures have forced me to make the decision to take my four-year-old to nearby Minneapolis in order to utilize the newer, better cared for playground facilities at Minnehaha Park where a great deal more parents and children can be found throughout the year. With a park (Highland) that is walkable to our house, this should not be the case.

Vandalism and decrepit structures suggest that a community does not care about its public facilities, a perception that might also translate to the lack of care the community has for itself. These factors create a negative experience for parents and children who then have to put in time and energy to travel elsewhere to play and socialize or find alternative activities. Speaking to this, I have noticed that aside from local school groups and a few parents and children, there is very little public use of the playground which is especially puzzling due to the increased traffic at the newly remodeled Highland Park Library.

Please upgrade our neighborhood facilities! Highland Park residents—which includes plenty of parents and children—deserve to have an outdoor space that is clean, beautiful, and reflects the pride we have for our community.

On behalf of the Highland Groveland Recreation Association (HGRA), I wish to lend our support for the 2014/2015 CIB proposal to develop an artificial turf athletic field at the Highland Park Community Center (HPCC).

Quite simply, the athletic field as it now exists is unacceptable for youth sports activities. It is especially unsafe for sports such as soccer that involve sliding on the field.

When I was a volunteer coach for recreation center soccer teams, I would line the players up before the game and we would walk the field collecting rocks that were on the surface. No matter how often we did this, there were always new rocks on field for the next game. Other groups also followed this practice and, as a result, together we accumulated quite a sizable pile of rocks during the season. Imagine trying to play a game on such a field.

The HPCC athletic field is used for many more recreational activities in addition to soccer. Each of these has to deal with the challenges presented by such a substandard field. Because it is considered a multi-purpose field, it is subjected to use throughout the year and gets no rest or time to recover from the extensive overuse.

The Saint Paul Parks and Recreation Department has recognized the difficulty of maintaining natural grass fields which are over-used in this manner. As a result, it has installed artificial turf fields at fields that were previously grass fields – McMurray Fields at Como Park, Jimmy Lee Fields – and it is considering installing artificial turf at the proposed multi-purpose field at Victoria Park.

HGRA provides recreational sports programs serving almost 2,200 youth in the Highland-Groveland area. Our numbers alone attest to the demand for open space that allows for safe and enjoyable athletic activities. Unfortunately, the Highland-Groveland area also has very limited open space for these activities which makes safe, playable fields at HPCC a necessity and will contribute to attracting families with children to the City of Saint Paul, thereby contributing to the vitality and growth of our neighborhood.

### Re: Statement of Support and Commitment for Hillcrest Park

Thank you for the consideration you have given to improving Hillcrest Park, as well for the conversations you have had to date with members of the community. The Highland Catholic School Mens' club is an organization of over 100 Highland Catholic School fathers and male guardians encompassing current and alumni families, Highland Business owners and parishioners of Lumen Christi Catholic Community. The club recognizes that public works projects are most impactful when private citizens are engaged and invested in such project's success. For this reason, we have written this statement of support and commitment for Hillcrest Park.

Hillcrest Park is located in one of the most vibrant neighborhoods of Saint Paul and in an area that has seen significant public and private investment of late. The popularity of the fields, proximity to a busy commercial center, school and renovated library, combined with the annual Highland fest and the presence of a very popular sledding hill, put significant strain on the equipment and fields. The current turf conditions and equipment are worn down and require improvements that align with the increasingly high utilization of the park. Therefore, as you debate and consider plans for the park, we would like to voice our support that the following elements be included in your final design:

- Safe but challenging playground equipment, including facilities that appeal to older children, as well as small child areas
- Fitness based activities, such as climbing walls, exercise stations and four square that encourage activity in both young and old park users
- Sustainable multi-purpose fields, including baseball, soccer, football– while grass is preferred, our hope is that any surface receives the proper maintenance (e.g., irrigation, removal of rocks, etc.); Artificial turf is preferred to a non-maintained natural surface
- Hockey rink and/or other winter activities that encourage Highland Park residents to be active year round
- Lighting that promotes safety and security, as well as increased nighttime utilization by recreation leagues, both children and adult

We recognize that each of your organizations operate on a budget and that there are many similar projects that warrant investment. Therefore, we are committed to partnering with you to build and maintain an improved Hillcrest Park through the following representative activities:

- Assemble playground equipment
- Monitor and maintain hockey rink (we understand that the community plays an active role at other successful rinks)
- Perform annual clean-ups or other basic maintenance

• Other volunteerism based tasks as needed

Furthermore, we appreciate and welcome a conversation about what financial commitments, if any, might be required to achieve the collective vision to be defined between our community, the Highland District Council and the Saint Paul Parks and Recreations department.

Current usage is estimated at over 100,000 and there are generally wait lists for programming on the fields.
