### 1. AGENDA, MINUTES, INTRODUCTIONS, ANNOUNCEMENTS

**a.** The meeting was called to order by Chair Trcka at 6:33 p.m.

- **b.** Commissioner Shively requested that Victoria Park no longer be a standing agenda item as the committee will not be meeting on a regular basis any longer since the master plan has been completed. A motion to approve the agenda as amended was made by Commissioner Mountain and seconded by Commissioner Goodlow. The vote was 5 to 0 in favor with three commissioners absent.

## a. Resolution 14-05 City of Saint Paul Bikeways Plan

Director Hahm introduced this resolution as a carryover from the February 2014 Commission meeting. At the February meeting it was decided to hold this resolution over until more of the community involvement meetings had been concluded. After discussion, it was decided that the resolution should be amended to read that "the Saint Paul Parks and Recreation Commission supports continued development and improvement of the bikeways plan." The commissioners expressed questions regarding the lack of detail in the implementation plan, including prioritization and funding, whether or not there is any use data available pertaining to improvements that have already been made, and the gaps in the system and when they will be addressed.





A motion was made by Commissioner Shively and seconded by Commissioner Marckel to approve Resolution #14-02 as amended. The vote was 7 to 0 in favor with two commissioners absent.
