## LEAD REPLACEMENTS

### INSTRUCTIONS FOR LEAD REPLACEMENTS:

Include the following amount with LEAD REPLACEMENT/OUTSIDE DITCH PERMIT:

**\$100 TURN ON RESET** for 1” and smaller water meters

**\$125 TURN ON RESET** for 1 ½” and 2” water meters

### DEFINITIONS:

<b>Base fee</b>	Minimum charge for each inside piping permit.
<b>City, List</b>	In addition to SPRWS plumbing permits and inspections in the City of St. Paul, permits and inspections are also required for all water services, water meters, inside and outside water piping in buildings located in the following cities: <u>Falcon Heights</u> , <u>Lauderdale</u> , <u>Maplewood</u> , <u>Mendota</u> , <u>Mendota Heights</u> , and <u>West St. Paul</u> ; also a few SPRWS accounts are located near boundary streets in Little Canada, Roseville, South St. Paul and Sunfish Lake.
<b>Fixture</b>	Shall be defined as including, but not limited to, the following: water closet, urinal, faucet, shower, dishwasher, drinking fountain, hose connection, sill cock, water heater, water softener, underground sprinkler, hot tub/spa, clothes washer supply, backflow preventer or any water supplied fixture.
<b>Fixture fee</b>	\$6.00 for each fixture installed. (This fee to be charged in addition to base fees on fixtures installed or roughed-in for new installations, additions, and rehabilitations). No fixture charge on repairs or well conversion.
<b>Lead Replacement</b>	Replacement of an existing lead water service. Check box marked Lead Replacement under <b>EXISTING BUILDING – OUTSIDE DITCH</b> . A <b>TURN-ON RESET</b> fee will also be required. In some situations an inside piping permit may be required by the plumbing inspector.
<b>Meter Setting Charge</b>	The charge for the first meter setting shall be the actual cost of the meter. This charge does not apply to meter resets.
<b>New Building</b>	New water piping and fixtures installed in a new building or an existing building moved to a new site.
<b>Outside Ditch</b>	Charge for each 75 foot (not prorated) increment of underground pipe installed by the plumber.
<b>SPRWS</b>	Saint Paul Regional Water Services.
<b>Well Conversion</b>	Installation of a city water connection to an existing building that has well water.
<b>Cut Off</b>	Physical severing and approved capping of the pipe.
