Approval for their use, a site plan, and an inspection prior to event start is required for <b>Tents larger than 200 sq. ft.</b> (tents have a roof and sides or drops on two or more sides). <b>Canopies larger than 400 sq. ft.</b> (canopies have a roof and are open or unenclosed on three or more sides). <i>If on parkland – permit required by Parks for any size.
