How do the Section 8 vouchers work? Does another property lose its vouchers? Some of the research should have follow-up.

Commissioner Bezat moved that the HPC concurs with the finding of No Adverse Effect for 170 Western Avenue South as per the findings of fact, presented testimony, submitted documentation and information provided in the staff report. Commissioner George seconded the motion. **Motion passed 6-0.**

B. Commission Discussion: Justice and Equity in Historic Preservation A virtual research symposium sponsored by the University of Maryland: School of Architecture, Planning & Preservation. The symposium highlights historic preservation research and activism centered on advancing justice and equity.

Commissioner Comments

Where does the disabled community fit in with historic preservation? The term public history needs to be better defined. Our common preservation language can't be focused in academia, it can't be jargon. It is necessary to have a high-level survey. Saint Paul needs to establish a group of grassroots preservationists. Need to reach out to underrepresented communities. We need to think about cultivating interesting ideas for participation. The focus needs to move off of a singular culture. Need to increase our education and outreach initiatives. Creatively think how to represent cultures that may not have a physical structures. We should consider a follow up listening session. The narratives of common workers should also be important to history. Work should focus on recognition of sites that are not Eurocentric.
