



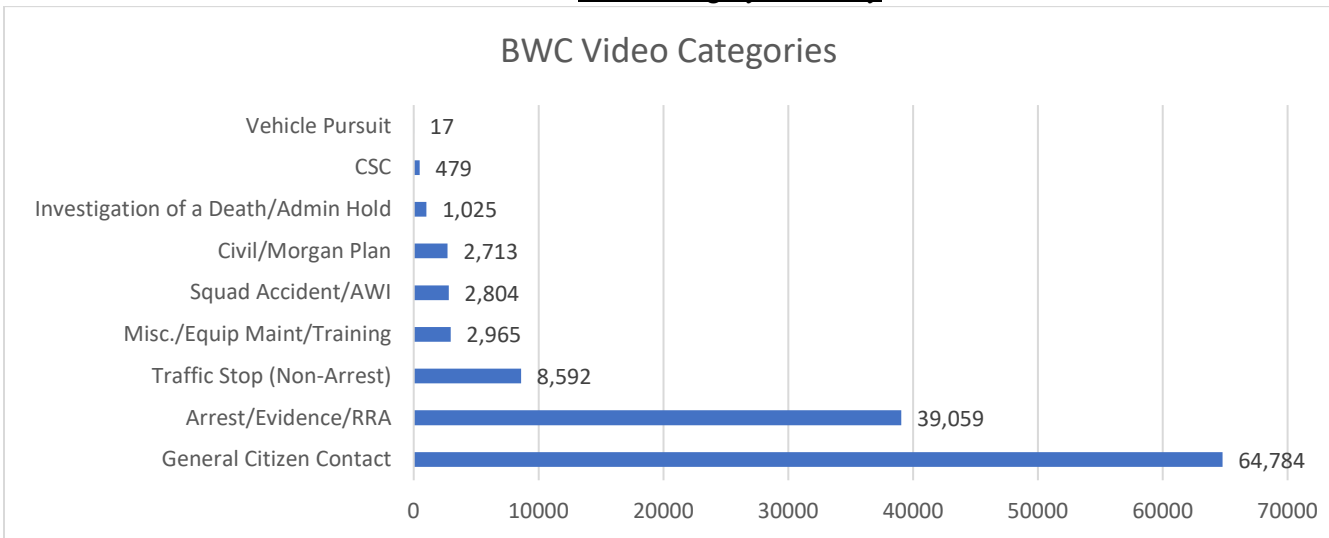
## 2021 – 2<sup>nd</sup> Quarter BWC Report
