The Master Plan will focus on a series of preferred cross sections, with emphasis for the Lexington to Victoria segment planned for reconstruction in 2023.

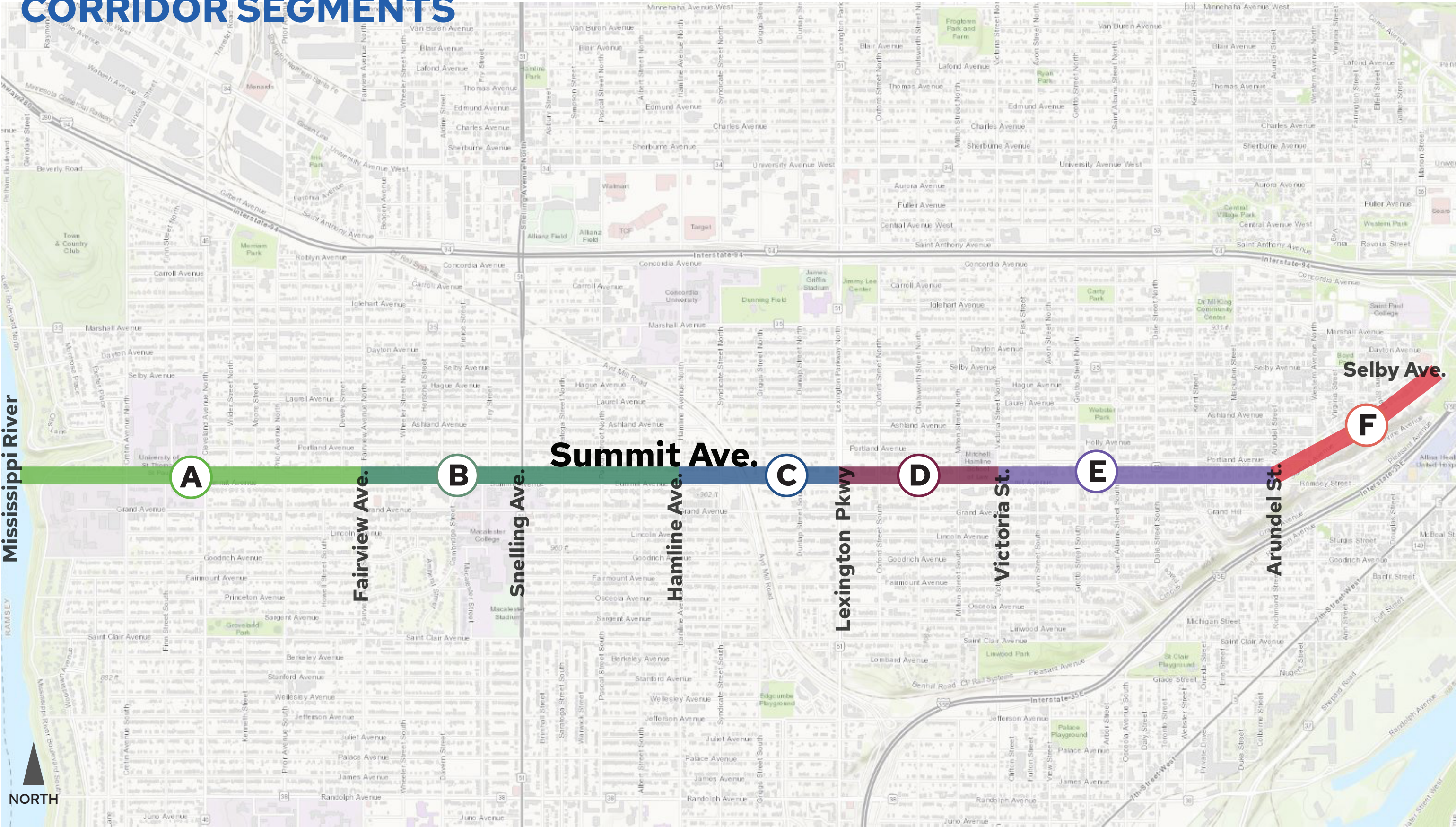

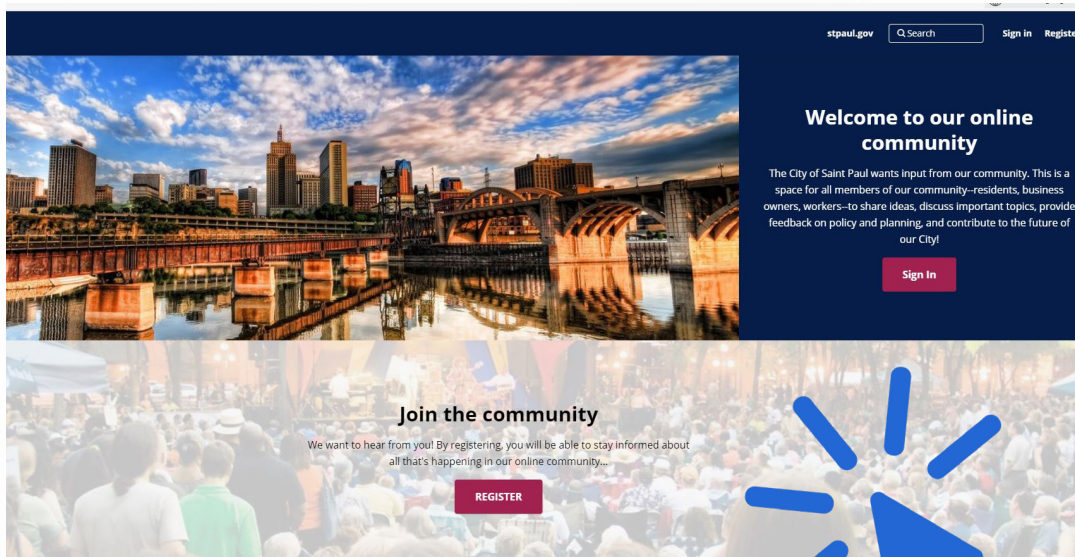
