- A. Applicant - Ashley Thao (21-327478)
 Location - 612 Burlington Road
 Zoning - R1/RC-3
 Purpose: Major Variance
 The applicant is proposing to construct a new single-family dwelling with an attached garage. The zoning code states that attached garages shall be set back from the front lot line as far as the principal structure; the proposed garage would project in front of the principal structure, for a variance of this requirement.

- B. Applicant - Saint Paul Blackhawks Soccer Club (21-330390)
 Location - 875 Orchard Avenue
 Zoning - R4
 Purpose: Major Variance
 The applicant is requesting a variance from the sign code requirement in order to install 7 wall signs on this property for the Saint Paul Blackhawks Soccer Club. The zoning code permits one (1) identification sign, not exceeding a total of thirty (30) square feet in area for each street frontage. This property has three street frontages, which allows a total of 3 signs, totaling 90 square feet. There is an existing 20 square foot freestanding sign on the southeast corner of the property. The proposed 7 wall signs and existing freestanding sign (8 signs total) would total 975.1 square feet, for a variance request of 5 signs and 885.1 square feet of signage.

- C. Applicant - Linn Investment Properties, LLC (21-327856)
 Location - 1647 University Ave West
 Zoning - T3
 Purpose: Major Variance
 The applicant is proposing to demolish the existing restaurant building and construct a new laundromat building. The following variances are requested: 1. The zoning code requires a minimum FAR (floor area ratio) of 0.5; a FAR of 0.213 is proposed, for a variance of 0.287. 2. The zoning code states that surface parking areas and entrance drives may occupy no more than sixty (60) feet of the total lot frontage; the proposed parking and entrance drive would occupy 103.5', for a variance of 43.5'.
