## INSTRUCTIONS FOR FEE CALCULATION

# **RE-DASH, PATCHING, SPRAY-ON FIREPROOFING, PLASTERING, STUCCO, VENEER PLASTER AND EXTERIOR INSULATION & FINISH SYSTEM:**

The fee shall be 1% of the estimated job cost with a minimum fee of \$79.00.

The state surcharge is based on the estimated cost of the project.

\$1.00 - \$1,000.00 is a flat 50¢ (minimum surcharge is 50¢)

\$1,001.00 & over is .0005 times the Estimated cost of the job.

Building Inspectors are in the office for inspection requests between 7:30 - 9:00 AM, Monday - Friday. 651-266-9002
