

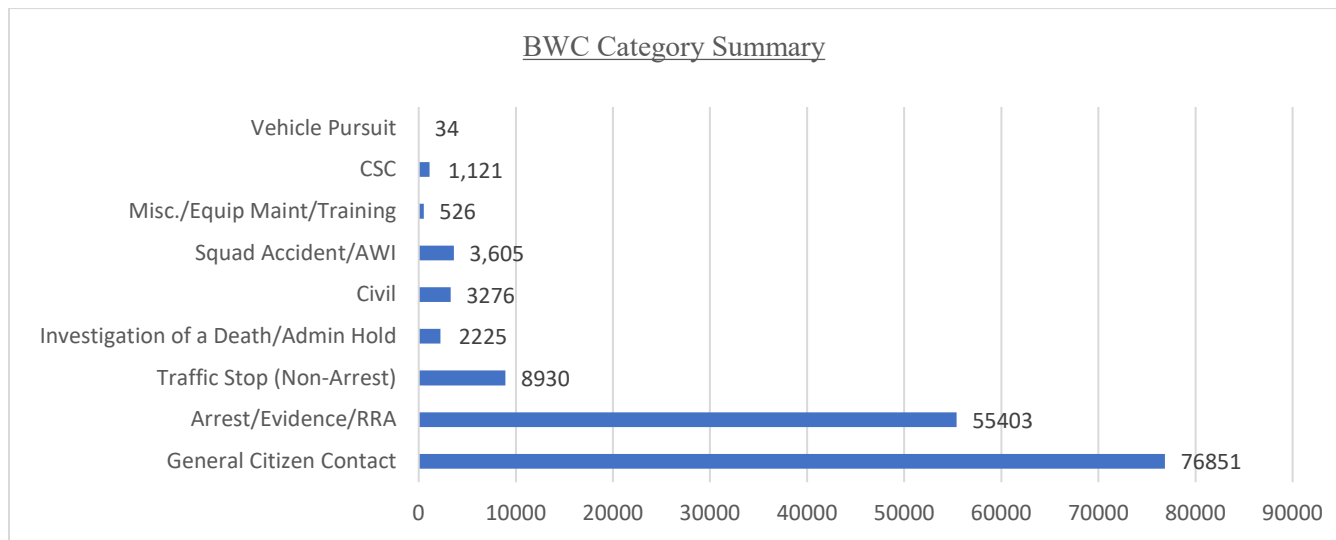


2022 – 2nd Quarter BWC Report
