

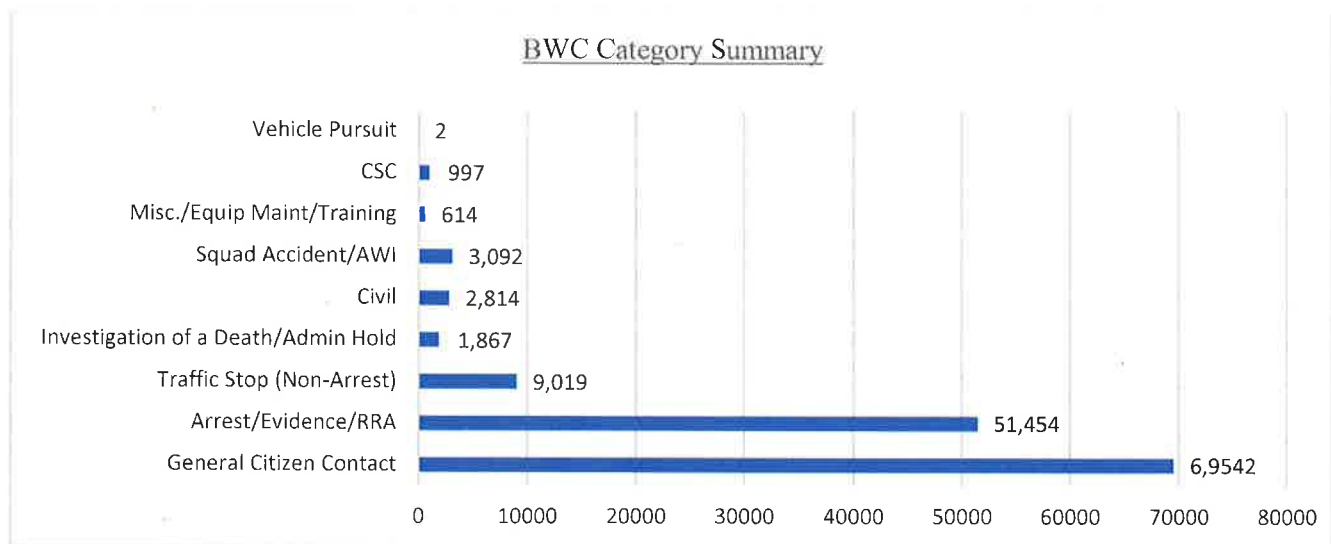


2022 – 3rd Quarter BWC Report
