## Substantial Amendment:

This substantial amendment incorporates changes to program year 2022 Consolidated Plan Annual Action Plan by adding projects, Public Facility: 100 10<sup>th</sup> St E and Public Facility: 1790-1800 University Ave, to the PY2022 Annual Action Plan. The substantial amendment also increases the CDBG Resources available by \$1,044,652 in previously receipted, unanticipated program income and reallocates funding from new construction housing and single unit rehab to public facility. Goal 10 Public Improvements will be increased by \$1,802,652. Goal 2/Project 6 Development of New Housing/Housing Construction will be decreased by \$533,000. Goal 4/Project 7 Homeowner Housing Rehab/Single Unit Rehab will be reduced by \$225,000. Project 15 Public Facility: 100 E 10<sup>th</sup> St. will be funded with \$758,000 Project 16: Public Facility: 1790-1800 University will be funded with \$1,044,652.

This substantial amendment incorporates a change to program year 2021 Consolidated Plan Annual Action Plan to reallocate 2021 CDBG funds and add public facility projects: 100 10<sup>th</sup> St E. and 1790 -1800 University. Project Administrative Funding will be decreased by \$72,740, Goal 4/ Project 7 Homeowner Housing Rehab/Single-Unit Rehabilitation will be decreased by \$75,000, Goal 8/Project 9 Economic Development will be decreased by \$86,000 and Public Improvements Goal 10 will be increased by \$233,740 and Public Improvement Project 100 10<sup>th</sup> St E will be funded with \$41,000 and Public Improvement Project will be funded with \$192,740.
