\$500,001 - \$1,000,000	\$4,899 for the first \$500,000 plus \$7 for each additional \$1,000 or fraction thereof
\$1,000,000 & Up	\$8,463 for the first \$1,000,000 plus \$5 for each additional \$1,000 or fraction thereof

STATE SURCHARGE:

Minnesota Statute 326B.148

<u>Value</u>	=	<u>Surcharge</u>
\$1.00 - \$1,000	=	\$0.50
≤ \$1,000,000	=	0.0005 x Job Value
> \$1,000,000	=	see statute

PLAN CHECK FEE:

Valuations ≤ \$1,000	=	no fee
Valuations > \$1,000	=	65% of permit fee from table above

This calculation is for the building permit fee only and does not include other fees that may be included to obtain your building permit. An example would be SAC, Parkland Dedication, Zoning and other miscellaneous required fees).
