(Without additional charge)

Free "Walk-Up" Service (without any additional charges) is allowed for residents who are physically unable to get the garbage cart to the designated collection location. By applying for this service, the resident is certifying that no one living at the property is physically able to get the garbage cart to the regular, designated curbside, or alley-side collection location. Walk-Up Service does not include bulky waste, yard waste, or any other materials not allowed in the garbage cart. It is the responsibility of the resident to ensure the garbage cart access is not obstructed by fences, vehicles, snow, dogs, or other items.

To be eligible for Walk-Up Service, your garbage cart "Walk-Up Location" must meet the following standards:

- Your garbage cart must be set out in a Location accessible to both you and our drivers.
- The Location must not require us to enter your home, garage, or other enclosed area to access your trash cart.
