In accordance with 24 CFR part 91, 24 CFR part 92, and CPD notice 21-10, the City of Saint Paul will have its proposed HOME American Rescue Plan (HOME-ARP) plan available for review and comment on April 20, 2023.

Saint Paul's proposed HOME-ARP Allocation Plan is made through a substantial amendment to the program year 2021 Consolidated Annual Action Plan. The City was awarded \$6,789,929 to address critical needs for homeless assistance and supportive services through the American Rescue Plan Act of 2021.

- tenant-based rental assistance (TBRA),
- 4. supportive services,
- 5. acquisition and development of non-congregate shelter, and
