In accordance with 24 CFR 91.105(b)(2) of the Consolidated Submission for Community Planning and Development Programs Final Rule, the City of Saint Paul will have its proposed 2024-25 Consolidated Plan - Annual Action Plan available for review and comment on March 1, 2024.

Saint Paul's proposed 2024-25 Consolidated Plan - Annual Action Plan is an application to the U.S. Department of Housing and Urban Development (HUD) for Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) funding, and serves as the City's planning document for the use of these funds during the 2024-25 program year.
