- Shaqaaluhu waxay urursadaan ugu yaraan 1 saac oo ESST ah 30kii saacadood ee kasta oo la shaqeeyo.
- Shaqaaluhu waxay bilaabaan ururinta ESST-ga maalintooda 1aad ee shaqada waxaana loo oggol yahay inay isticmaalaan ESST urursan kadib markii ay u shaqeeyaan 80 saacadood sannadkii loo shaqeeyaha.
- Loo-shaqeeyayaashu waa inay u oggolaadaan shaqaalaha inuu ururiyo ugu yaraan 48 saacadood oo ESST ah sannad kasta oo uu sii wado ilaa 80 saacadood saacadaha ESST ee aan la isticmaalin kadib sanadka koowaad ee shaqaalaha.
- Dukumeenti ayaa waxa kaliya oo la codsan karaa ESST-ga maqan in ka badan 3 maal mood.
