2024 Lead Free SPRWS to Remove Lead Water Service Lines in 1,293 Homes

Saint Paul Regional Water Services' Lead Free SPRWS program, a 10-year plan to replace all lead water service lines in the SPRWS service area, has an ambitious goal for 2024.

In 2024, the goal is to remove lead service lines in 1,293 homes. This is about the same number as have been replaced in the first two years of the program.

Water service lines are pipes that carry water from the water mains in the street into homes/buildings. SPRWS serves about 96,000 properties. Of those, about 26,000 have a lead service line.

Water leaving the water treatment plant does not contain lead. However, since the water has the potential to interact with lead if customers have a lead service line or lead solder in their internal plumbing, SPRWS treats the water to create a protective scale. While this process helps minimize lead, the best way to protect from lead entering drinking water is to remove all lead service lines.

The Lead Free SPRWS



program will provide voluntary, no cost replacement of both the public and private side of lead service lines. This work is being funded through an allocation of American Rescue Funds and Public Facility Authority funds.

Homes that are eligible in 2024 will be notified by mail.

Board to Hold Public Hearings on Water Rates

Every year SPRWS holds a public hearing on the proposed water rates and fees for the upcoming year.

This year that public hearing will take place at 5 p.m. on Tuesday, Sept. 10, 2024, at SPRWS, 1900 Rice Street, Saint Paul, MN 55113.

This discussion on rates and water fees as they relate to the overall budget will be followed by the regular Board of Water Commissioners meeting, in which the board may vote on the 2025 budget, including the rates and fees proposed for 2025.

This public hearing is an opportunity for customers of the SPRWS water service system to hear first hand about how the changes to rates and fees may impact them and to provide feedback to the Board.

Water Quality Report Available Online Paper Copies are Available Upon Request

The annual water quality report that lets our customers know what is in their water, where it comes from, and how they can participate in decisions that affect the water utility, is now available.

"We take great pride in the quality water we provide to our 450,000 customers in Saint Paul and surrounding area," said Racquel Vaske, interim general manager.

The EPA requires that water suppliers provide consumers with an annual report detailing all substances detected in the water in the prior year.

The report contains information about the sources of SPRWS water, as well as methods of water treatment and distribution. It also provides detailed information about contaminants and other substances found in the treated water through regular testing done by SPRWS and the Minnesota Department of Health.

Customers should read the report to find out more about their drinking water.

"This report should instill a sense of confidence in the drinking water we supply," said Vaske.



The report should also instill a sense of the importance of drinking water and protecting the raw water sources that provide that drinking water.

The drinking water covered in this report is provided by SPRWS to its customers in Saint Paul, Falcon Heights, Lauderdale, Lilydale, Maplewood, Mendota, Mendota Heights, and West St. Paul.
