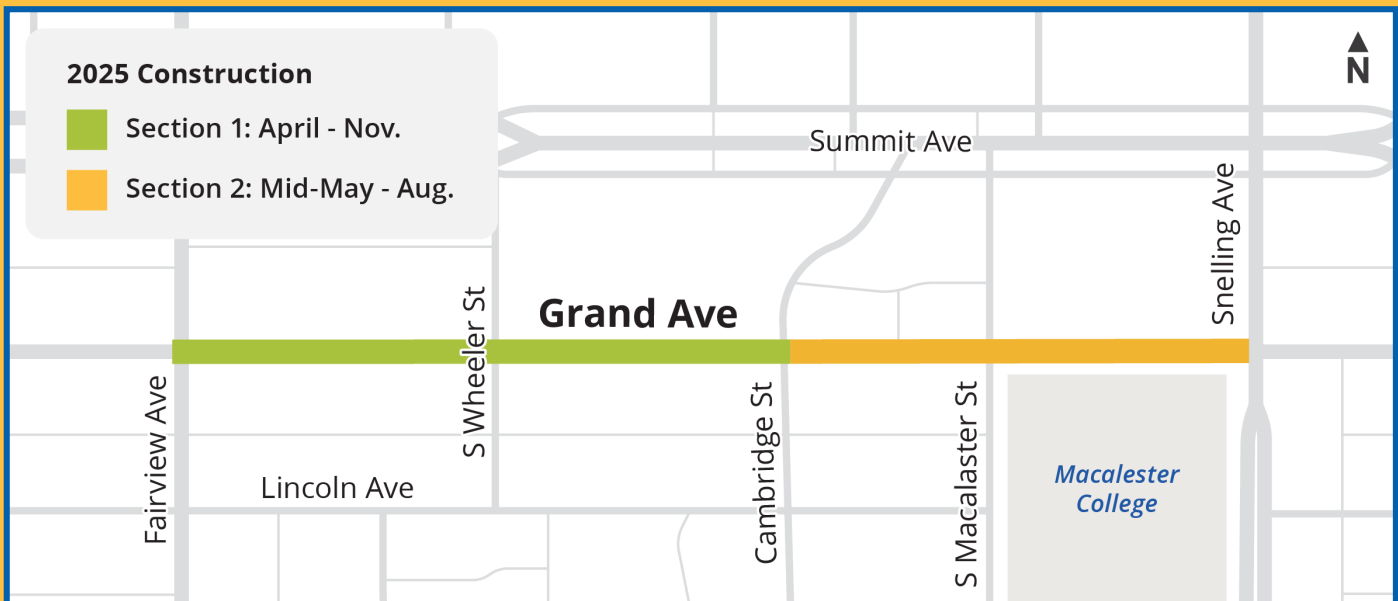


Project overview

Infrastructure and safety improvements for everyone are being made to Grand Avenue between Fairview and Snelling avenues. Construction is scheduled to begin in April 2025 and continue through November 2025.



2025 construction

Construction will be completed in two sections to stay on schedule while maintaining access to businesses, properties, and Macalester College. Utility work will be done in coordination with construction activities in both sections.

What to expect during construction

- Access to businesses and properties will be maintained; alternative access points and detours will be used
- Access to properties for deliveries will be maintained; alternative access points and detours will be used
- No parking on Grand Avenue; please use side streets
- No sidewalk patios will be allowed
- Anticipate increased traffic on neighborhood streets
- Pedestrian access will be maintained; follow posted pedestrian routes around the work zone
- Expect dust, noise, and vibrations

Metro Transit routes will be detoured off Grand Avenue.

Grand Avenue Street Reconstruction

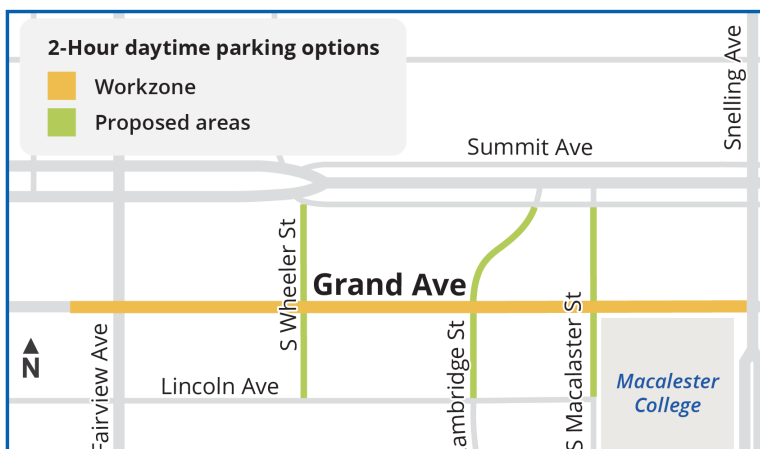

Grand Avenue is open for business

Access to businesses will be maintained throughout construction, but alternative access points and detours will be used.

- Deliveries will use the alley or side streets
- Businesses can direct customers to the nearest side street for parking
 - ▶ The City is proposing adding additional 2-hour parking spaces one block north and south of Grand Avenue along Wheeler, Cambridge, and Macalester streets
 - ▶ Any existing parking restrictions will remain in place
 - ▶ These spaces will be enforced and may be adjusted as needed around Grand Avenue and side streets
- Sidewalk patios will not be allowed during construction
- General business signage will be installed around the project area

Cambridge Street to Snelling Avenue
