This is your 2025 invoice for the Storm Sewer System Charge. This charge pays for the operation and maintenance of the storm sewer system that includes drainage ways, ponds, lakes, the river, flood preventive measures, catch basins, storm sewer pipes, and curb & gutters. The Storm Sewer System Charge also funds programs to improve the quality of storm water runoff as required by the City’s federal storm water permit and local watershed districts.

2025 Storm Sewer System Charge Rates

Use Class	Property Type	Rate
A	Cemeteries, golf courses, parks, unimproved vacant land, and one- and two-family residential land in excess of 1/3 acre	\$220.25 per acre
B	Railroad land	\$440.51 per acre
C	Residential, one- and two-family homes (less than 1/3 acre)	\$131.68 per parcel
D	Condominiums and town homes	\$88.57 per unit
E	Schools and community centers	\$1,208.96 per acre
F	Multiple dwellings, religious buildings, government buildings	\$1,613.54 per acre
G	Commercial and industrial land, parking lots	\$2,173.71 per acre

For residential properties, the Amount Due is a fixed amount per parcel or per unit. For all other properties, it is calculated by multiplying the rate-per-acre by the property acreage (Land Area). Residential properties over 1/3 acre are charged the per parcel amount for the first 1/3 acre and the per acre amount (Use Class A) for the land over 1/3 acre.

Green Infrastructure Stormwater Districts pay an additional surcharge that is utilized to operate the public storm sewer system specific to that district.

How can I pay?

Note: We do not accept payment by phone.

When is my payment due?

Payment is due by November 15, 2025. If you do not pay by that date, the Amount Due plus a 5.95% interest charge will appear on your 2026 property tax statement. Payments received after November 15th may be returned to the sender.

What if I think my invoice is incorrect?

If you pay a per acre rate and think you qualify for a discount based on the Storm Sewer System Charge Policy, you may contact Public Works Sewer Utility at 651-266-6234 to request a review. This request must be done by August 4, 2025.
