The City of Saint Paul has implemented Residential Permit Parking in various neighborhoods throughout the city. Permits are only available to residents and homeowners within the permit area.

Permit Areas are designated by "No Parking – Except Holidays – Except by Permit – Area Number" Street Signs. (Note: Signage may vary but all contain "Except by Permit"). The Area number on the street sign **corresponds to the Area on the Permit**.
