# NOTICE OF FINDING OF NO SIGNFICANT IMPACT AND NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS

These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by the City of Saint Paul.

## REQUEST FOR RELEASE OF FUNDS

On or about December 1, 2025 the City of Saint Paul will submit a request to HUD for the release of Community Development Block Grant funds under 42 U.S.C. 4321, et seq., of the National Environmental Policy Act of 1969 as amended, to undertake a project known as the Ramsey County Lead Window Replacement Program FY'24-25 that is anticipated to treat 34 units in Saint Paul. Lead poisoning can cause permanent damage to the brain and many other organs and can result in reduced intelligence and behavioral problems. A large portion of children at risk are in families of low income and are living in older housing units with heavy concentrations of lead-based paint. The most common sources of childhood exposure to lead are deteriorated lead-based paint and lead-contaminated dust, and soil in the residential environment. This program will help protect children from exposure to lead. Ramsey County will enroll qualifying properties that will undergo lead hazard reduction activities following HUD's Window Replacement and Low Impact Stabilization Program guidelines. The primary focus of this program is to do lead hazard reduction work in units with children under six years of age. Ramsey County will manage the rehabilitation activities of enrolled properties until lead-based paint clearance testing is completed and work has been performed in a satisfactory manner, including payment of contractors and collection of lien waivers. The program goal is to reduce the incidence of undue lead absorption of children living in Saint Paul. Total funding for the project is \$450,000 using 2024 CDBG funding. The size of the units and extent of lead-based paint will have an impact on the total number of units remediated.

#### FINDING OF NO SIGNIFICANT IMPACT

The City of Saint Paul has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Comments should specify which Notice they are addressing.

#### **ENVIRONMENTAL CERTIFICATION**

The City of Saint Paul certifies to HUD that Yasmine Robinson in her capacity as Planning Director and in her official capacity as Certifying Officer consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows Aeon to use Program funds.

### **OBJECTIONS TO RELEASE OF FUNDS**

HUD will accept objections to its release of fund and the City of Saint Paul's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Saint Paul; (b) the City of Saint Paul has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to HUD via email at <a href="mailto:Lucia.M.Clausen@hud.gov">Lucia.M.Clausen@hud.gov</a>. Potential objectors should contact HUD to verify the actual last day of the objection period.
