



## PUBLIC NOTICE and OPPORTUNITY FOR COMMENT

The City of Saint Paul proposes to construct a trail from Battle Creek Regional Park at the Northernmost point along Battle Creek Regional Park Entrance Road to Bailey Road. The proposed project will construct a new off-street multi-use trail between the north end of Point Douglas Road and Bailey Road in Saint Paul, connecting to a trailhead and picnic area at Battle Creek Regional Park. This trail will create a continuous off-street connection between Saint Paul and Washington County, linking major segments of the regional bike commuter and recreational trail systems while reducing conflicts between vehicles and trail users. The project includes excavation, construction of the trail, stormwater drainage improvements, and the addition of amenities such as lighting, benches, bike racks, trash receptacles, an underpass at Lower Afton Road, and ADA-compliant curb ramps.

In accordance with Section 6009 of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) Public Law 109-59, enacted August 10, 2005, the City of Saint Paul is soliciting comments on the effects this project would have on Battle Creek Regional Park. The project would include De Minimis impacts and temporary easements in the southwest corner of the Battle Creek Regional Park parking lot at the north end of Battle Creek Park Entrance Road, where trailhead access is located.

It is anticipated that the City of Saint Paul will request the Federal Highway Administration (FHWA) to determine that the proposed action at Battle Creek Regional Park is a Section 4(f) de minimis action in accordance with Section 6009(a) of SAFETEA-LU. A *de minimis* finding may be made when uses of Section 4(f) land will have no adverse effect on the protected resources.
