CLOSES: Friday, August 4, 2017 or earlier if leagues fill

ENTRY FEE: \$270.00 Includes 8 referred league games and playoff tournament

\$320.00 Non-resident teams

Teams with more than one player that does not live or work in Ramsey County are considered a

non-resident team. Non-resident teams must pay an additional fee of \$50.00 per team.

LEAGUE PLAY: Thursday's, September 7 – October 26, 2017

Game start times between 6, 7 or 8 pm (3 sets to 25 each week)

DIVISIONS Women and Co-Rec (8 teams in each division)

(B) Players have ability for multiple hits & offensive plays. Good team play. Less challenging

than A. Rules will be enforced more than C level.

(D) For beginning teams who have not played much together and are developing their skills. Good team play. Less challenging than C. Rules are structured but are loosely enforced.

PAYMENT: Payment will be accepted (Cash or Credit Card) and must be made in full at the time of

registration. No reserving spots without payment. Any team registering that drops before schedules are drawn will be refunded their entry fee LESS \$25. Teams withdrawing from the league after schedules are drawn will be refunded their entry fee LESS \$100. Once league play

begins, there are NO refunds.

PLAYOFFS: Playoff tournament will be Sat., Nov. 4. Teams will automatically be entered into the playoffs

unless the team manager chooses to opt out. Teams will be seeded for a Single Elimination

Tournament after the 7th league game.

ROSTERS: Roster are limited to 13 players. Rosters must be turned in prior to your first game. Fax it to

ELIGIBILITY: Players MAY play on more than one team during league play. However, during playoffs players
