ESST Task Force Minutes Thursday May 26, 2016

- I. Welcome
 - A. Convened at 6:10pm
 - B. Brief overview of today's meeting and recommendations
- II. Review and approval of minutes from previous meeting
 - A. Minutes passed

III. Discuss and vote on proposed amendments to recommendations

- A. Discussion on amending the recommendation to move, "c. Employees with a collective bargaining agreement (CBA) are covered by this ordinance and are not exempted," under item 2 of Scope or Ordinance. Proposed new wording, "Employers and employees with policies or agreements in place (such as paid time off, PTO, or collective bargaining agreements) that meet the minimum requirements as outlined in the ordinance, would be deemed compliant".
 - 1. VOTE:
 - a. Yes: 22
 - b. No: 0
 - c. Abstain: 0

*Unanimously agreed on the amendment of CBA statement

- B. Discussion on exempting casual employees
 - 1. Add an exemption for casual employees, at least to the limited extent that Minneapolis included in their draft ordinance. **Motion withdrawn*
- C. Discussion on increasing the threshold to 80 hours until an employee can start accruing ESST to align with Minneapolis's ESST
 - 1. Employees will have to work at least 80 hours until they can start accruing ESST.
 - 2. VOTE:
 - a. Yes: 12
 - b. No: 11
 - c. Abstain: 0

*Task Force will amend the recommendation threshold from 1 hour worked to 80 hours worked in order to start accruing ESST.

D. Discussion on adding a recommendation that employees who can foresee the need to take ESST, that they submit a seven days of advance notice to help accommodate scheduling a replacement.

- 1. When ESST is used for preventative care, 7 days of advanced shall be given.
- 2. VOTE:
 - a. Yes: 6
 - b. No: 16
 - c. Abstain: 0

*Recommendation does not pass and will not be part of the recommendation.

- E. Discussion on aligning St. Paul's ESST as much as possible with Minneapolis. **This item was later withdrawn after discussion*
