7. Warbixinta Bulshada iyo Aanan aheyn Bulshada

Waxaa lagu weydiiyay inaad si qitiyaar ah u sheegtid warbixinta loo isticmaalayo in lagu eego cabashadaada. Warbixintaan waxay quseysaa Xeerka Dhaqamada Xogta Dowlada Minnesota. Sharcigaan wuxuu qeexaa warbixinta gaar, ee ku jirii karta warbixinta adiga kugu saabsan, sida shaacsan. Inkastoo aanan loo heli karin bulshada, waad hali kartaa warbixinta aad sheegtay. Haddii ay jirto tallaabada edbinta ugu dambeyso kbaaritaanka buuxo, sababaha loogu soo rogayo edbinta ugu dambeyso waxay noqoneysaa mid shaacsan oo waa lagu helayaa.
