PROJECT OVERVIEW


Saint Paul and Dakota County have teamed up to plan for the creation of a new bicycle and pedestrian trail that will fill several important gaps in the region's trail system.

The new trail segment will connect the Harriet Island Regional Park and its trail system to Kaposia Landing Park in South St. Paul. The project will also make improvements to the connection between the Lilydale Park trail and the Big Rivers Trail in Dakota County.

The completed trail is expected to become part of the Mississippi River Trail, a multi-state bike trail that begins at the Mississippi River's headwaters at Itasca State Park and extends, adjacent to the river, all the way to the Gulf of Mexico.

TRAIL ALIGNMENT + FEATURES

- Grade-separated, 10' wide multi-purpose trail, approx. 3.7 miles in length.
- Structures include pedestrian overpass bridge in South Saint Paul and two boardwalk bridges in Saint Paul.

CONSTRUCTION UPDATES

Construction efforts began in September 2019 beginning in Lilydale with the build-out of Trail Segment A. While this is a small stretch of trail, this segment provides an important link in connecting the Big Rivers Regional Trail to Lilydale Regional Park.

The winter months have been busy building bridges! The pedestrian bridge bringing trail-users over railroad tracks and into Kaposia Landing Park is well underway. Two boardwalk bridges are being constructed while the ground is frozen in the wetland area between Holman Field and Southport.

When Spring arrives, crews will begin construction of the trail along Plato Blvd. in Saint Paul. Starting at Water Street, construction is anticipated to move east towards Highway 52 and the East Lafayette Frontage Road.
