Project Name: Replacement of Bridge No. 90378 Eastbound Kellogg Blvd at RiverCentre
Geographic Scope: Ward 2, Districts 9 and 17, Kellogg Blvd (Eastbound) from W. 7 th Street to Market Street

Project Description: Reconstruction of approximately 1000 feet of Bridge No. 90378 and associated approach roadways, Exchange Street Viaduct, retaining walls and RiverCentre loading dock exit road, rehabilitation or replacement of signals at Washington Street and RiverCentre Parking Ramp intersections.
Project Stage & General Timeline: Conceptual design completed, preliminary design under development. Timeline: Design and approvals completed by June 2021. Shovel ready by Fall 2021. Construction start depends on funding availability.
Public Hearing Date & Location: Will occur during design phase, included in City Council approval process.
Cost & Primary Funding Source(s): Total Estimate Project Cost: \$23.6M (including design) Funding Sources: Federal, State Bridge Bonds, MSAS, CIB Design schedule is governed by federal grants deadline of June 2021. The project must address a \$10.4M funding gap prior to bidding. City has requested special state legislative funds in 2020.
