

CULTURAL STAR PROGRAM

- In May 1993, The Minnesota State Legislature authorized the City of Saint Paul to levy an additional half-cent sales tax.
- 10% of STAR revenue goes toward Cultural STAR program
 - Targets nonprofit arts and cultural organizations
 - 80% goes to "Cultural District of downtown Saint Paul"
 - Programming, operating, and capital expenses
- 2020 General Operating Fund
 - One-time emergency relief program
 - Deadline: Friday, October 2nd at 4pm





GENERAL OPERATING FUND - ELIGIBILITY

- Located in Saint Paul
- Tax-exempt nonprofit 501(c)3 organization
- Registered with MN Secretary of State
- Primary art/culture-centered purpose, or major arts-based initiative, program or project
- Impacted by COVID-19
- Annual operating budget of \$5 million or less



GENERAL OPERATING FUND - ELIGIBLE USES


- Rent/mortgage and/or utilities
- Accounts payable
- Employee expenses (payroll, earned sick and safe time, health insurance)
- Program expenses:
 - Artist payments
 - Virtual programming
 - Marketing
- Any other operating/program expense





GENERAL OPERATING FUND - FUNDING

- Minimum grant award amount \$5,000; No match
- 80% of funds awarded to organizations located within the Cultural District of downtown, and organizations that received a Cultural STAR grant designated as a Cultural District investment between 2015 and 2019
- **Remaining 20%:** Nonprofits located outside of the Cultural District




