**URBAN DESIGN** is the thoughtful arrangement of the public realm, or the public spaces between buildings (including parks, streets and sidewalks). Good urban design - the interaction between private development and public space – fosters activity, connection, beauty, safety and economic value.

# Focus: Aging in Community



AGING IN COMMUNITY means that residents can stay in their community as they age. The entire community – not just a house or neighborhood – becomes a resource for health and activity. When people "age in community," they continue to use the resources of their community – housing, transportation, services, shopping, health care, recreation – to stay active, healthy and engaged.
