Project Name: Robert Piram Regional Trail

**Geographic Scope:** Connecting Bike and Ped Trail between Harriet Island to South St. Paul and an improved connection between Lilydale and the Big River's Trail

**Project Description:** Side path bicycle and pedestrian trail that will connect between Harriet Island Regional Park and Kaposia Land Regional Park in South St. Paul/ Dakota County. Project will use Federal Surface Transportation Act (STP) and local matching funds to build trail, provide landscaping and build a boardwalk bridge across a wetland and a larger bridge over Railroad right of way. Project will also include interpretive signage and a public art component.

**Project Stage & General Timeline:** Project originally scheduled for construction in 2017 but due to the complications of railroad negotiations and the need to acquire some easements, project funding was extended to 2018. Project must be authorized by MNDOT state aid by May of 2018 for biddding to follow. Construction could begin in late summer or early fall of 2018.

#### Public Hearing Date & Location: N/A

**Cost & Primary Funding Source(s):** \$4.5M to \$5.2M depending on the St. Paul/Dakota split on the federal STP funding. Grant funding was through a joint application between the City of St. Paul and Dakota County.

#### **Transportation Committee Role:**

**Explanation** Some unanticipated conflicts in our ability to provide an at grade railroad crossing, forced us to revise the trail alignment necessitating the acquisition of several right of way easements. The easements we are seeking are mostly on land that is already impacted by existing utility easements. Securing these easments remains the most challenging aspect of the completing the project design and presents significant unknown costs at this time.






Harriet Island to South St. Paul Regional Trail Master Plan Amended Trail Alignment Proposed UP Rail Crossing at Barge Channel Rd.















