If you are completing this application for an event to be held on National Night Out, Tuesday, August 1, 2017, follow the instructions carefully. If you have questions not answered in these instructions, call the Community Engagement Unit at 651-266-5485, or the coordinator for National Night Out in Saint Paul, Pam McCreary at 651-266-5455.

- ➤ There are **NO FEE'S** for the Class B Permit, barricades, or registration if the event is held on Tuesday, August 1, 2017. If your neighborhood chooses to do an event on another date, there will be charges attached to the permit process.
- ➤ ALL Class B Permits <u>MUST</u> have the signature of 60% of the neighbors in the area that would be affected by barricades being in place. *No exceptions!*

AGREEMENT AND CERTIFICATION

IT IS HEREBY AGREED:

- I. Agreement of Applicant(s): The applicant(s) agree to abide by all rules set forth below, together with all ordinances and other rules and regulations which may be imposed governing such activities.
- II. Regulations of Use: By signing and presentation of this application, the signer(s) certify to the City of St. Paul that the following statements are true and correct and signer (s) agree to and will abide by the following:
- A. <u>Barricades</u>: Barricades provided from the City or private vendor will be dropped off on one corner of the block. The applicant(s) will be responsible for placement, maintenance, and removal of the barricades. Barricades should be placed at both ends of the street during the public gathering. Homemade barricades may be used only on NNO when permits are granted and public works has run out of city barricades.
- B. <u>Traffic</u>: The total roadway portion of the right-of-way shall not be blocked: at least a ten (10) foot aisle shall be kept open at all times to permit passage of vehicles of residents of the block and emergency or other authorized or necessary vehicles to enter and exit.
- C. <u>Surface of Street</u>: No materials of any type (such as powder, sawdust, etc.) shall be placed on the public right-of-way which will create hazards.
- D. Supervision: Applicant(s) shall maintain adult supervision at all times during this activity.
- E. <u>Clean Up</u>: Applicant(s) shall provide trash receptacles to prevent as much littering as possible. Applicant(s) shall be responsible for the pick up or disposal of trash and garbage following the event. Such clean up shall be completed within twenty-four (24) hours after termination of the activity, but in no event later than midnight following the day of the public gathering. If the City is required to clean up, the permit holder will be billed for all costs!
- F. Hours: Streets may not be barricaded prior to 8 a.m. nor later than 10 p.m. in any event.
- G. Speakers: Sound systems/speakers may be used on National Night Out but no later than 10 p.m.
- H. <u>Accessibility</u>: The event organizers are required to make reasonable accommodations for persons with disabilities at this event, for example, in the areas of parking, restroom facilities, curb ramps, and access to food and entertainment.
- III. <u>Indemnity Agreement</u>: The applicant(s) agree to indemnify and hold harmless the City of Saint Paul, Minnesota, its agents and employees, from any and all claims, demands, actions or cause of action of whatsoever nature or character arising out of or by reason of the conduct of the public gathering in any respect, including costs, attorney's fees, expenses, etc., incurred in connection with the defense or settlement of any claims for injuries or damage resulting from or connected with this public gathering.
