#### Griggs-Scheffer Paving Project Phase I

#### What is happening?

The project will reconstruct streets in your neighborhood.

#### When is it happening?

Your street will be under construction in 2020.

#### How will the project impact you?

The project will improve the street pavement, curb and gutter, street lighting, sidewalks, water mains, and storm sewers.

#### How is the project funded?

The project is predominately funded by street reconstruction bonds as well as assessments to the abutting property owners. Your assessment estimate is unknown at this time but will be mailed in the spring with your public hearing notice.

## PROJECT DETAILS

### Street widths and sidewalks

Streets will be reconstructed at a width of 32 feet, comparable to the residential streets in the area. The project proposes to fill sidewalk gaps adjacent to segments of the reconstructed roadway.

### Sewers

Property owners are responsible for their private sewer lines that are in the roadway and connect to the city's main sewer line. Because the street is being reconstructed, this can be a good time to do needed or preventative work/repairs on your private sewer line. We encourage everyone to have their sanitary sewer connection inspected to verify its condition.

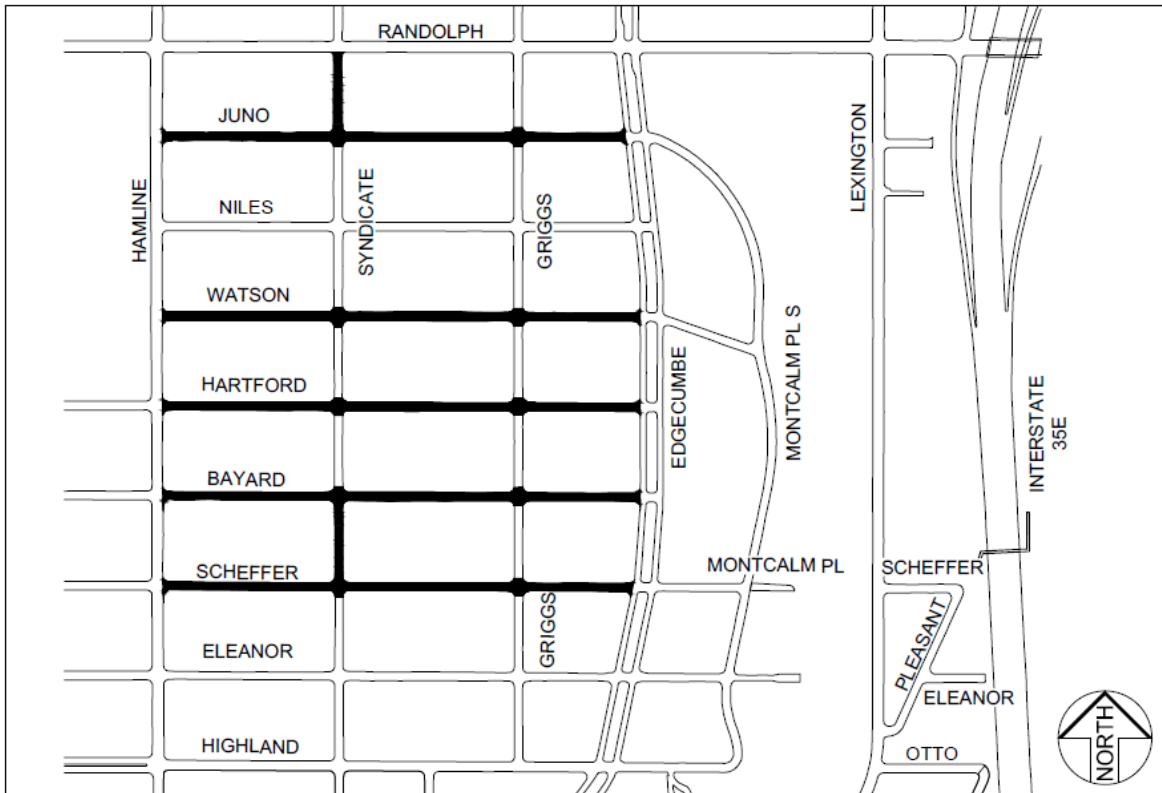
An information package with a request form for the work that can be completed as part of the project was sent to all property owners in the fall of 2019.

### Water service

Saint Paul Regional Water Services (SPRWS) will replace all lead water services from the water main to the property line at no additional cost to the property owner.
