SIDEWALK WORK NOTICE

As part of a city street resurfacing project, Saint Paul Public Works has contracted Concrete Idea, Inc., — a company licensed, bonded, and insured with the city — to construct new pedestrian ramps which meet the requirements of the Americans with Disabilities Act. Certain locations will have additional pedestrian improvements such as curb bump-outs. These improvements may impact existing grass, trees, and/or landscaping located within the public right-of-way (the boulevard area between the street and sidewalk).

When will work begin and end? Pedestrian ramps will be constructed between July 22 and October 31, 2019 on the following streets: Prior Avenue between Summit Avenue and Roblyn Avenue, Cleveland Avenue between Mississippi River Boulevard and Yorkshire Avenue, and St. Clair Avenue between Fairview Avenue and Snelling Avenue. Prior to construction, residents may see survey stakes or paint markings in the street or grass to mark the public right-of-way and existing utility locations.

How will this work impact you?

- The contractor may begin work as early as 7:00 a.m., weather permitting.
- Temporary “No Parking” signs could restrict parking during daytime hours to provide a safe work zone for the contractor.
- Expect disruption to the boulevard, including the removal of grass or materials in the area surrounding the new sidewalk.
- **For properties with underground sprinkler systems located in the public right-of-way:** Please help reduce damage by informing the contractor of any sprinkler heads near the work area. Per your sprinkler permit, it is the property owner’s responsibility to repair any damage that occurs during the normal course of city maintenance or construction.
- **Restoration of the areas around sidewalks will be topsoil and sod:** The city will not restore gardens or brick pavers located in the public right-of-way.
- If a portion of your driveway needs to be reconstructed for the sidewalk work, **you will not have access to your driveway during construction and concrete cure time.** The contractor will notify you prior to the work starting so you may move vehicles if necessary. Every effort will be made to minimize the amount of time you are without driveway access.

What should I do to take care of my sidewalk?

- Before they can be used, sidewalk panels need at least 24-hours, and driveway crossings need 5-days, to cure.
- Do not write, walk, bike, or mark the concrete in anyway.
- Please clear snow and ice from the sidewalk during the winter months.
- Please water new sod as needed.
