

City of Saint Paul Sewer Assessment Program Packet

Program Information and Instructions

Who is eligible?

- Any City of Saint Paul property owner who owes **no delinquent taxes** on a property in need of any of the following work done.
 - Repair of an existing sanitary sewer service.
 - Replacement of an abandoned or removed sanitary sewer service that is or was located along the alignment of a previously functioning sanitary sewer service. Please note that this program cannot be used for the construction of a new sanitary sewer service along an alignment that previously did not have a functioning sanitary sewer service.
 - Disconnection of a rainleader.
 - Rerouting of a private storm sewer service from the City's sanitary sewer system to the City's storm sewer system.

Participation in this program is voluntary. Property owners have the option to arrange for private financing. Feel free to call the Sewer Utility at 651-266-6234 to verify that you qualify to use this program.

What are the eligible costs?

- Only costs (parts, labor, restoration, etc.) deemed necessary for performing any of the work listed above.

What forms need to be filled out and returned to the Sewer Utility?

- Before any work is done, the following must be submitted to the Sewer Utility for review and approval:
 - An application form (included in this sewer assessment packet) signed by the property owner.
 - **At least three estimates** (previously one) are now required for all private sewer repair work \$8,000 or higher. A list of licensed sewer contractors who are authorized to perform this type of work is included in this sewer assessment packet. Please call them for estimates. Contact the Sewer Utility by phone at 651-266-6234 to discuss your estimates. Note that the decision of which licensed sewer contractor ultimately performs the work belongs to the property owner.
- After the work is completed, the following must be submitted to the Sewer Utility for processing by the property owner:
 - A Repair Completion form (included in this sewer assessment packet) signed by the property owner.
 - A copy of the final invoice of the work performed by the licensed sewer contractor.

How does the contractor get paid?

- After the work is completed and all required forms are received and approved by the Sewer Utility, the City's Finance Department processes and mails out a check to the contractor on the property owner's behalf (see the included Repair Completion form).

How does the property owner pay for the work done?

- The City's Real Estate Division processes a special assessment for the cost of the work done and sends it to the City Council for ratification. The ratified assessment is then certified to the County, with charges appearing on the property owner's real estate tax statement the following year.
- The current fixed interest rate for this program is 3.25%. This rate is set by the City Council and is subject to change without notice. An administrative fee of \$60 is added to the total cost of the work done.
- Through real estate property taxes, the property owner pays the charges (sum of the cost of the work done, \$60 administrative fees, and 3.25% interest charges) over a twenty year period, starting the year after the City Council ratifies the assessment.
- Payment in full without penalty can be made any time prior to end of the twenty year period.
- An example of how this program works is included in this sewer assessment packet.

Application for Sewer Assessment

As owner of the property listed below, I have reviewed the Sewer Assessment Program instructions and agree to the following terms and conditions:

Administration Fee: I will be charged a one-time fee of \$60.00 for administration, which will be included in the cost assessed against my property.

Payback period: Cost of work performed, administrative fees, and interest will be collected through my real estate taxes over a twenty-year period. Interest charges will be based on the fixed rate approved by the Saint Paul City Council and is subject to change without notice. The current rate is 3.25%. I may pay the unpaid balance in full at any time during this twenty-year period, without penalty.

Waiver of Appeal: I AGREE TO WAIVE MY RIGHT TO APPEAL THIS ASSESSMENT. I AGREE TO SIGN AND SUBMIT THE REPAIR COMPLETION FORM PROMPTLY UPON COMPLETION OF MY SEWER REPAIR WORK. THE CITY WILL NOT BE RESPONSIBLE FOR ANY CHARGES THE LICENSED SEWER CONTRACTOR MAY LEVY FOR FAILURE TO RECEIVE PAYMENT PROMPTLY DUE TO THE PROPERTY OWNER NOT SUBMITTING ALL REQUIRED DOCUMENTS ON TIME.

Damage Awards: If the work performed was necessitated by damage resulting from the actions of another party, and I collect compensation from that party, I agree to apply the full amount collected towards the unpaid balance of the assessment.

Payback period: I understand that the contractor's cost, the City administrative fee, and interest charges will be collected through real estate taxes over a twenty-year period. Interest charges will be based on the fixed rate approved by the Saint Paul City Council and is subject to change without notice. The current rate is 3.25%. I also understand that I may pay the unpaid assessed balance in full at any time during this twenty-year period without penalty.

Waiver of Appeal: As owner of the property listed below, I agree to waive my right to appeal this assessment.
