Sidewalk Construction is Happening in Your Neighborhood in 2020!

Washington Tech Safe Routes to School Project

What is happening?

The project will add sidewalks and improve pedestrian crossings in your neighborhood. See project map on reverse side.

When is it happening?

Tree removal work will begin in February 2020. Sidewalk work is planned for May through August 2020.

How will the project impact you?

The project will add sidewalk and improve pedestrian crossings. Please expect short-term disruption of travel ways by people, materials, and equipment. Full street closures are not expected; however, street parking will have temporary bans as the work is underway.

What's the cost?

The total *estimated* cost of this project is \$1.275 million. The project is funded by local and federal sources. There are no assessments for property owners.

PROJECT DETAILS

Street widths and sidewalks

Sidewalks will be constructed near the edge of the street right-of-way with a tree boulevard. ADA-compliant pedestrian ramps will be constructed.

Parking and driveways

Please watch for temporary parking bans to allow construction crews to move in and out of your neighborhood quickly and safely. The parking bans will start in February 2020.

Property owners who have driveways impacted by project construction will be notified in advance to any temporary access issues.

Existing boulevard gardens and sprinklers

If you have personal property, plantings, or sprinkler systems in the public right-of-way, remove them. Otherwise, they may be damaged during construction. The project will not replace or repair damages to property in the public right-of-way.

Trees in the boulevard

Because of Emerald Ash Borer, all Ash trees in the area will be replaced with other varieties. Additional tree removals may be necessary where they conflict with sidewalk. Trees will be replanted as part of the city's urban forest plan. Contact the City's Forestry Division at 651-632-2437 with questions.


