# Construction is Happening on the Woodlawn-Jefferson Phase I **Paving Project**

# What is happening?

Street reconstruction on Woodlawn Avenue, Mount Curve Boulevard and Jefferson Avenue.

### When is it happening?

Work is expected to begin June 18, 2018. The contractor will begin work on Woodlawn Avenue and on Jefferson Avenue first, then move on to Mount Curve Boulevard and Montrose Lane near the end of July.

# **IMPORTANT INFORMATION**

### **Driveway Access**

There will be times when access to your driveway is not possible. You will receive further information on this as the work progresses.

### **Landscaping Items and Sprinkler Systems**

If you have landscaping items in the boulevard right-of-way, please remove them prior to construction. Keep these items stored until the sodding and boulevard/sidewalk work has been completed. Any items left in the boulevard will be removed and disposed of by the contractor.

If you have an underground sprinkler system in the boulevard or public right-of-way, it is your responsibility to remove the system before the contractor begins work, repair the system if the contractor damages it, and replace the system after the contractor has completed placing sod in the boulevard or right-of-way. Where there is no sidewalk, the sprinkler system should be removed two-to-three feet behind the right-of-way or city property line.

### **Parking Restrictions**

Parking restrictions may apply — please be mindful of signs posted.

### **Recycling and Garbage Collection**

Set materials close to the street on your scheduled pick up date.

#### Sod

Sod that is placed is guaranteed by the contractor for 30-days. You will receive a flyer with more information on the care of your new sod prior to the sod being placed.

### **Work Day Schedule**

The typical work day is 7:00 a.m. to 7:00 p.m. Monday through Friday. There may be occasions when working past this time or on weekends is necessary.
