A. Applicant - **Robert J. Eisbach** (#18-067539)

Location - 1715 Field Avenue

Zoning - R3

Purpose: MINOR VARIANCE - The applicant is proposing to construct an attached

pergola on the east side of an existing single-family dwelling in order to screen utilities. A minimum side yard setback of 6' is required in the R3, single family residential zoning district. The house has an existing setback of 4'; a setback of 0' is proposed,

for a variance request of 2'.

B. Applicant - Manana Restaurant 2 LLC (#18-067547)

Location - 798 7th Street East

Zoning - T2

Purpose: MAJOR VARIANCE - The applicant is proposing to install a new

projecting sign on the northwest side of existing building for Manana restaurant. The zoning code limits the maximum display area to 16 square feet per side for a projecting sign in the T2, Traditional Neighborhood zoning district; the proposed sign would be 36 square feet per side, for a variance

request of 20 square feet.

Location - 334 St. Clair Avenue

- R4: RC-4 Zoning

Purpose: MAJOR VARIANCE - The applicant is proposing to construct a new single-family dwelling with an attached, two-car garage on a vacant lot and is requesting the following variances: 1) A front yard setback of 25' is required; a setback of 17' is proposed, for a variance request of 8'. 2) A side yard setback of 4' is required in the R4, single family residential zoning district; a setback of 3.2' is proposed, for a variance request of .8'. 3) This property is located in the RC-4, River Corridor Overlay District and a minimum setback of 40' from the bluff line is required; a setback of 39' is proposed, for a variance request of 1'. 4) The zoning code states that a garage door that faces a public street may not be more than 60% the width of the house (15.3'); the proposed garage door would be 63% (16') the width of the house, for a variance request of 3% (.7').

The proposed shop would be 2,400 feet from a similar shop at 956 Rice Street, for a variance request of 240 feet.
