

SPRWS – Serves Region

Saint Paul Regional Water Services provides water services to the City of Saint Paul and nine surrounding communities. For five of the surrounding cities, the water system is owned and operated by SPRWS. In the case of two communities, SPRWS supplies water on a retail basis and then has agreements to operate these systems. The last two communities are provided water through wholesale agreements. Saint Paul Regional Water Services was created in 1865.

In addition to supplying water to communities, SPRWS offers consumer billing services. The billing services are customized so each community can select the optional charges to include in the bills provided to their consumers. Examples of optional charges would be sanitary and storm sewer fees.

Water System

SPRWS produces an average of 43 million gallons of drinking water per day and distributes it through more than 1,200 miles of water main. The system serves approximately 425,000 people.

SPRWS obtains its water from four major sources: (i) the Mississippi River, (ii) the Rice Creek chain of lakes north of Saint Paul, (iii) the Vadnais Lake area watershed, and (iv) a series of wells. The treatment plant was constructed in 1920-22 and has been enlarged and modernized over the years.

Board of Water Commissioners

SPRWS is governed by a seven member Board of Water Commissioners. The Saint Paul officials are appointed by the Mayor, subject to approval by the City Council. The suburban members are appointed by their respective City Councils.

Financing Plan

- **Sale of Water**

There is no change in the projected volume of water to be sold in 2019. Total consumption base is at 1.65 billion cubic feet (BCF). There is a \$0.09 per CCF increase in the consumption based rates. The rates per 100 cubic feet are as follows:

- **Water Service Base Fee**

There is no change in the Water Service Base Fee. The monthly fee is at \$6 per month for typical residential customers. This fee is based on the size of the meter. The fee increases as the meter size increases to reflect the added cost of providing peak volume capacity.

- **Water Main Surcharge**

There is no change in the water main surcharge. The rate is \$0.20/100 cubic feet.

- **Right-of-Way Recovery Fee**

There is no change in the Right-of Way Recovery Fee. This fee remains at \$1.50 per month. This fee is based on the size of the meter.

- **Impact of Rate Adjustments on Typical Residential Customer in Saint Paul**

Assuming an average annual consumption of 68 units (50,864 gallons), the impact on the typical residential customer is an increase of approximately \$6.12 per year for a total cost of \$301.48. This consists of the following:

Spending Plan

- **Operations and Maintenance Costs**

Operations and maintenance includes all expenses we incur to operate and maintain the water system. This includes salaries and fringes, services, and miscellaneous costs.

- **Revenue and Debt Funded Capital Investments**

Revenue funded capital projects include replacement and improvements of buried infrastructure, raw water conduits, treatment processes, water towers, pump stations, safety improvements, water meters, technology, and other small capital and equipment.

Debt funded capital projects include process improvements at the McCarron's treatment plant. Improvements include the construction of new softening basins, recarbonation basins and ozone disinfection.

- **Debt Service and Miscellaneous Costs**

On December 31, 2017 SPRWS had total outstanding debt of \$39.3 Million. Other miscellaneous costs include financing lead service replacements.
