As with any recycling company, Eureka may become involved in litigation matters that are incidental to the operation of its recycling business. During the past 10 years, Eureka has been subject to one lawsuit alleging wrongful termination of employment, which settled. In addition, Eureka was a party to a lawsuit with a plaintiff pedestrian who alleged being injured by a Eureka recycling vehicle. That claim was also settled without material impact to the business operations or to Eureka's financial position.

5) Within the past five (5) years has the company or, in the case of a joint proposal one of the proposers submitting this proposal, been cited for/required to pay Liquidated Damages or other penalties for failure to comply with service or other provisions of an agreement or agreement? If yes, list these actions and explain their nature and disposition.

In the past five (5) years, Eureka has only incurred minor liquidated damages charges for missed stops associated with the service provided to the City of Saint Paul, resulting in approximately seven instances per month.

Eureka Recycling has two lines of business; recycling collections and recycling processing

Eureka Recycling is a nonprofit zero waste organization and social enterprise recycler based in and providing services to Minnesota's Twin Cities. Through a local workforce of more than 135 employees, we have provided recycling and zero waste services and education to the Twin Cities and surrounding areas since 2001. We are one of only a handful of nonprofit recyclers in the United States and are dedicated to preventing waste through demonstration, education, and advocacy. Our Material Recovery Facility (MRF) processes approximately 400-500 tons of recycling every day to create feedstock for regional and national supply chains.
