**PROPOSED 2026-27 CONSOLIDATED PLAN - ANNUAL ACTION PLAN AND HOME-
ARP ALLOCATION PLAN AMENDMENT AVAILABLE FOR REVIEW**
AND NOTICE OF PUBLIC HEARING

In accordance with 24 CFR 91.105(b)(2) of the Consolidated Submission for Community Planning and Development Programs Final Rule, the City of Saint Paul will have its proposed 2026-27 Consolidated Plan - Annual Action Plan available for review and comment on March 1, 2026. In addition, In accordance with 24 CFR part 91, 24 CFR part 92, and CPD notice 21-10, the City of Saint Paul will have its proposed substantial amendment to HOME American Rescue Plan (HOME-ARP) plan available for review and comment during the same time.

Saint Paul's proposed 2026-27 Consolidated Plan - Annual Action Plan is an application to the U.S. Department of Housing and Urban Development (HUD) for Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) funding, and serves as the City's planning document for the use of these funds during the 2026-27 program year.

The proposed 2026-27 Consolidated Plan – Annual Action Plan and proposed substantial amendment to the HOME-ARP Allocation Plan is available for review during a 30-day public review and comment period from March 2, 2026 to April 1, 2026, at <https://www.stpaul.gov/conplan>. The HOME-ARP substantial amendment adjusts funding priorities to the development of affordable rental housing. Citizens wishing to submit written comments during the public review and comment period may mail them, postmarked no later than April 1, 2026, to the following:
