# Pelham Boulevard Reconstruction: Virtual Office Hours on 1/20

December 15, 2025

## **Project Overview**

In 2026, the City of Saint Paul will be reconstructing Pelham Boulevard between Mississippi River Boulevard and Franklin Avenue. The project will replace underground utilities, as well as the sidewalks, street surface, curbs, lighting, and pedestrian ramps. An off-street bikeway at sidewalk level will be added to the east side of Pelham, and the flexible white posts currently in the street will be removed. The design is largely guided by the Grand Round Design and Implementation Plan (2017), and the Saint Paul Bicycle Plan (2024).

### **Project Costs and Funding**

A portion of this street reconstruction project will be paid for by a 1% local sales tax, called Common Cent. This sales tax was approved by Saint Paul voters in November 2023. A portion of the project will also be funded through assessments to property owners abutting the project area. Properties without frontage on Pelham will not be assessed for any costs.

The estimated assessment rate for your property and information about the public hearing at City Council is included in this mailing. After the project is completed, property owners will receive the special assessment bill. This bill will not exceed the estimated assessment rate included in this mailing.
