


# 2025 – 4th Quarter BWC Report

## Mandatory Recording Audit Summary

SPPD conducts weekly audits to ensure officers are recording per the [BWC policy](#). Follow-up occurs in all cases of potentially missing video to identify whether or not a policy violation exists.
